

# Fraud, Waste and Abuse

## *If you suspect fraud, report it!*

There are three types of fraud:

### **FRAUD**

When someone tricks or deceives others on purpose to get money or personal benefits illegally.

Examples:

- Using someone else's Medi-Cal for services.
- When a doctor submits bills for a service that he/she did not provide

### **WASTE**

Using medical resources carelessly or inappropriately.

Examples:

- Providing more services or prescribing more medication than what is medically needed or appropriate.

### **ABUSE**

Purposely ignoring or going against the natural and legal rules for how something should be used.

Examples:

- Providing services or medications that are not medically indicated or necessary.
- Disclosing a patient's personal health information without consent.
